The proposal along with rate quotation and attested copy of certificates (State Pollution Control Board NOC, Registration Certificate and any other relevant documents issued from competent authority) for collecting such e-Waste is invited from certified/Government approved e-Waste collection agencies involved in Recycling of e-waste.

2. The bidder shall abide by the rules to be declared at the time of auction. Reserve/base price will be reveled only at the time of auction. Successful bidder will deposit full amount to vvn account of PM SHRI Kendriya Vidyalaya No.1 Bathinda Cantt and partial bid will not be accepted in any case.
3. KVS employee and their relative are not allowed to participate in the auction process.
4. The bidder will have to deposit valid ID proof like Aadhar card/PAN card/Voter ID etc.
