Subject: Conduct of Learning Achievement Test II- 2024-25-regarding.

Madam/Sir,

In continuation with letter no. F11- Acad0338T(7)/1/2019/AC(TRG)/1242-70, dated 23.04.2024, the second Learning Achievement Test (LAT-2) of classes 3, 5, and 8 for the session 2024-25 is scheduled to be conducted on **22.10.2024 at 11 AM**. Double shift schools will ensure that the LAT 2 test for both shifts is conducted simultaneously.

The question papers for LAT-2 will be based on the content covered in the first term in the current academic year. The format and standards for the paper will be similar to that of LAT 1 paper held in April 2024.

The following are the key aspects of LAT 2.

1. **Assessment Items:** The assessment items will consist of multiple-choice questions, with one correct response.
2. **Alignment with the Content Covered from April to September 2024 (Term I):** The test will focus on foundational concepts from the 1st term of the current academic session and will be aligned with specific learning outcomes of those grades.
3. **Cognitive Skills:** The items will cater to a range of cognitive skills, moving beyond mere recall or memorization, to promote deeper understanding and critical thinking.

Furthermore, it is imperative that the sanctity of the test is maintained. To ensure a smooth conduct of the test, the Regional Offices are expected to ensure:

- **Prompt Delivery of Question Papers:** Regional offices are required to send the question papers to the schools one day prior to the date of the test. They should provide clear directions to the schools for making necessary arrangements such as riso machine, photocopier, printer, etc.,

for printing of question papers according to the strengths of classes 3, 5, and 8 of their respective schools.

- **Overall Report Preparation:** The overall report of the test should be prepared at both- the school and the Regional Office level for further necessary action. The schools should prepare the result in excel sheets using the same format that was used in the LAT 1. The report should be ready in the school with in one week after completion of the LAT 2 test and no later than 2 weeks at the Regional Level.

Password-protected question papers will be sent to the Regional Offices shortly, and the scoring key will be e-mailed on October 22, 2024. Assessment should strictly be based on these keys and the result should be prepared at the school level.

It is expected that LAT 2 2024-25 will be conducted smoothly and help the teachers and school leaders get an insight into developing strategies for academic uplifting and holistic growth.
