# CLASS - II & onwards Admissions 2025-26

For Classes II onwards Registration Schedule is-02/04/2025 to11/04/2025. (OFF LINE MODE up to 04:00 pm)

As per the Vacancy position of each class (except XI) as on 31/03/2025 and will be intimated by 1<sup>st</sup> April 2025.Accordingly the process of admission for vacant seats for respective classes will be completed as per the admission Guideline given by KVS.

<u>Vacancy as per NEW Admission Guidelines</u>-Subject to availability of vacancies as on 31-03-2025

### **Required Documents**

The following documents need to be submitted at the time of the admission in Class 1.

- Printed copy of online form
- Birth certificate (compulsory for all)
- Caste certificate of child (ST/SC/OBC- (NCL Non-creamy layer)
- Student's photograph (in jpg format) 02
- EWS/BPL card (for EWS/BPL applicants from RTE)
- Proof of residence (electricity bill, quarter allotment, rent agreement, ration card, Gas connection etc.)
- Service certificate
- Transfer count certificate
- Aadhaar card, Blood group
- The undertaking of parents on a **distance of residence from school (for RTE applicants**)
- Original TC & (PEN number) of previous class (In case of class II and onwards) during documents verification – if any vacancy exists.

### **NOTE**

- (i) Mere registration will not confer a right to admission.
- (ii) Incomplete application forms shall normally be rejected.
- (iii) Admission secured on the basis of any wrong certificate shall be cancelled by the Principal forthwith and no appeal against such case will be entertained.
- (iv) For admission to class I, the registrations will be done through online mode. If multiple registration forms are submitted for the same child in the same Kendriya Vidyalaya, only the last application will be considered.
- (v) In respect of Category I, II, III, IV and V admissions the veracity of the Certificates submitted by the parents in proof of their service must be invariably verified by the Principal.
- (vi) The documents submitted by the parents/guardians of the children, provisionally selected for admission, are to be meticulously examined to ensure the authenticity and validity of the same, particularly those related to eligibility criteria
